

MINUTES OF THE ANNUAL PARISH MEETING JANUARY 28, 2018

The Reverend Susan McCone opened the meeting with a prayer.

The meeting marks the 223rd year of St. John's Church in Washington, Connecticut.

The meeting was well attended with 31 qualified voting members present.

The Minutes of the 2017 Annual Meeting were accepted.

The slate of officers and Vestry members was presented. There being no nominations from the floor, the Clerk of the Vestry cast one vote for the unanimous acceptance of nominations. The vote was seconded and the slate was elected as presented.

The members elected to the Vestry are as follows: Rebecca Bent for a term of three years; Darcy Campbell for a term of three years; Charles Dubow for a term of three years.

The Treasurer's Report for 2017 and the proposed budget for 2018 were presented as approved by the Vestry. These were available in printed form in the Annual Report along with charts showing the allocation of the projected income and expenses for 2018. Ms. Parkin said that the budget may be modified if that is required.

Mr. Dubow provided background information about the problems with the septic system. These are being addressed.

Mother Susan reported that a family service once a month on Saturday is off to a good start. She explained that the service is held on Saturday because there are sports on Sunday.

Ms. McFeely spoke about the St. Elizabeth's Guild. New members are always welcome as are ideas for projects.

She also thanked everyone who worked on the Bazaar.

Mr. Gillepie thanked Mother Susan, Ms. McFeely, Ms Parkin and others, including Mr. Brown, Mr. Wessely, and Ms. Gandt for all that they have done.

Following a prayer, the meeting was adjourned.

REPORT ON THE CAPITAL CAMPAIGN FOR 2018

David Gillespie ~ Susan McFeely ~ Hunter Brown ~ Mary Davis

Due to a transition year at St. John's, little progress was made to raise additional funding for the Capital Campaign. It is our hope that we will be able to strengthen our focus on the Campaign in 2019.

Extensive masonry and stone work still remains to be done in order to restore the exterior walls of the Church. It is estimated that this work will cost approximately \$500,000-\$600,000. The work that needs to be done includes removing all loose flagstone and biological growth, as well as all painted masonry coating, residual chemical sealants; cutting out old and deteriorated mortar joints to a minimum depth of ¾ inch, or back to sound, solid back-up material (not to exceed 1 inch depth); and re-pointing all mortar joints found to be open, shelled, cracked, damaged, deteriorated or otherwise defective. It is estimated that at least 15% of all joints will require re-pointing at the front and side entrances to the Church (Narthex and Vestibule), and that all cracked, damaged and deteriorating stones need to be replaced with new stone that matches existing surrounding stone.

BUILDINGS AND GROUNDS REPORT FOR 2018 Charles Dubow

The Grounds & Maintenance committee has nothing to relate for the annual report. Aside from the normal creaking and decay of an old building, the church and its property seem to be in relatively decent condition.

We had a frustrating day in November when we tried to rake leaves--thanks to Darcy, her husband Chris, and their kids for their invaluable assistance!--and we will aim to have a more comprehensive clean-up in the spring. Hopefully it will be less windy!

Finally, it is our hope that with the expansion of our choir St. John's can this year begin to offer one or more choral presentations and events in concert with groups from other churches in the area.

HOSPITALITY COMMITTEE FOR 2018

Sally Futh has organized coffee hours for many years and retired in April, 2018, after which I took over. She did a wonderful job and is a hard act to follow. Coffee hour consists of a team of two providing coffee and tea plus seasonal drinks (iced tea, lemonade, cider, egg nog), varied cheeses and dips with crackers or chips, sweets, fruit, and bite size sandwiches, though not all on the same day. Certain days have appropriate items such as hot cross buns on Good Friday, or cake and champagne for a wedding anniversary like the Fuths' last December 30th.

During this year, some new parishioners have volunteered and there are always friends to help when needed. Thanks to Jorge cleaning up the kitchen and refrigerator, it has been easier to put everything together on Sundays and clean up afterwards. We are always looking for new volunteers as some are away in the summer or winter. Volunteering for coffee hour is easy and fun. You get to know other parishioners, some of whom are good cooks! If anyone would be interested, please let me know. Seasoned volunteers or I will partner with newcomers to get them started.

OUTREACH REPORT FOR 2018

Véronique Dulack

Thanks to everyone's generous and growing participation, the St Elisabeth Guild expanded its outreach mission.

Contributions to The Warren Food Bank which serves the local community including Washington.

- We collected monthly supplies of food and other items most sought after to fill the current needs of the Warren Food bank. Lists of the needed supplies, depending on the time of year, are included in the weekly eblast. It is useful to know that most of the families they serve are households of just 1 or 2, so smaller jars and containers of nonperishable foods are preferred (canned vegetables, fruits and soups, cereals and pasta, pasta sauces, condiments, juice, sugar, flour. Hygiene and cleaning products).
- 12 pies were donated to supplement the Thanksgiving Food Basket.

Our partnership with The Covenant to Care for Children

During the course of the year, St John participated in meeting the needs of children on specific occasions. These are children facing poverty-driven issues whose families are among the working poor. *Covenant to Care for Children* (www.covenanttocare.org) is an organization based in Hartford (with local chapters) which provides and distributes statewide essential goods for children from birth up to 18 years. Every child's need is identified and reported by a social worker, allowing us to respond directly to the recipient's specific requests. A list of the suggested supplies are provided by the Covenant to Care organization.

• Christmas and Angel Tree: chaired by Marlene Smith

33 children ranging in age from 3 to 16 received gifts from St. John's parishioners. We learned that having gifts delivered early in December was better than later in the month when the Christmas rush was happening. We also learned that in some cases, requests for gift cards to specific stores proved to be difficult. We found that a simple solution is to purchase Visa or MasterCard cash cards at Staples, Office Depot, CVS. That will be carefully explained in 2019.

The generosity of many St.John's parishioners helped make Christmas a bit brighter for the children served and we look forward to expanding our participation next year.

- Easter Baskets. Will be chaired by Natalie Dyer in 2019 Over 32 Easter baskets filled with toys, books and writing supplies were distributed to children age 3 to 5.
- Back to School Backpacks: chaired by Véronique Dulack.

In early August, 32 backpacks filled with school and drawing supplies and books for children age 2 to 5 were donated. This is one of the most important drives of The Covenant to Care who distributes over 850 backpacks. statewide each year. We are looking forward to increase our participation next year
