

# • 100% responsibility for own learning

• What you get out of this experience is up to you.

# • Practice "both/and" thinking

• Try holding seemingly contradictory ideas simultaneously. See if you can use "and" in place of "but."

# Notice both process and content

• Be attentive to how things are said as well as what is said. Also notice what may be missing.

## • Be aware of intent and impact

• Well intended comments are not always received as such. We need to be mindful of the impact we can have on others. Say "ouch" when someone says something that hurts, or "wow" when someone says something that surprises you.

# • Maintain confidentiality

• What is said here stays here. It is not appropriate to tell someone else's story.

#### Sara Coles

Sara Whipple Coles was born and grew up in Washington, DC. She graduated from George Washington University, first with a degree in Classical Humanities & Greek, and later as a Physician Assistant. She had a 30-year career practicing as a Physician Assistant until she retired in 2011.

In 2005, Sara and her husband, Bob, moved to the Northville section of New Milford in order to be closer to both of their families. Sara immediately began to attend St. John's church, where she has been active ever since. Sara and Bob were active choir members from 2008 until 2018, and currently sing occasionally for special services. Sara has been a lector for 15 years, was a regular participant in the Monday discussion group, served as parish representative to the Diocesan Convention and on the Altar Guild for the past year. Last year she resumed her lay religious studies with Education for Ministry, after having begun the program several years ago.

Sara was raised as a Unitarian, was baptized into the Greek Orthodox Church in Athens at age 21, lived in Greece during the 1970's, and was an observant Orthodox Christina for 10 years; she was received into the Episcopal Church in 2009 by Bishop Laura Ahrens.

Sara and Bob both sing with the Kent Singers; Sara also serves on the Boards of both the Kent Singers and the Northville Resident's Association. They live in their 200-year-old house with several cats.

#### **Mary Graham Davis**

Mary and her family moved to Washington Depot in 1996. Her husband passed away in 2011. She has an extended family of two sons and three stepsons, and thirteen grandchildren! She has attended St. John's since arriving in Washington.

She grew up on the North Shore of Chicago, graduated from Mount Holyoke College and holds a Master's Degree in International Economics from the Fletcher School (Tufts University). She had an early career in banking and private equity in New York and Sydney and has been an organizational and change management consultant for the past 30 years, now operating her own firm in New York City.

She has significant board experience on the non-profit side as a Chair of the Board of Mount Holyoke College for two terms, President of the Graham-Windham Child and Family Services (New York), elected member of the School Board, Winnetka, Illinois, President of the Mount Holyoke College Alumnae Association, and on the for-profit side as a board member of Jannota, Bray and Associates (Chicago) and NED BioSystems Inc. She currently serves as a senior governance and board consultant for the Association of Governing Boards and Universities (Washington, DC).

She enjoys golf at the Washington Club.

#### **Andris Kalnins**

Andris grew up in Windham County, making him a lifelong Connecticut resident. A graduate of the University of Connecticut and the Harvard School of Business, Andris has a longstanding career as a Managing Director of the Chase Manhattan Bank in both the Aerospace and Domestic Institutional Banking Groups. Subsequently, he was a Senior Vice President at Moody's Investor Services from which he just retired. An avid reader of history, Andris also loves to garden and grow organic vegetables. He enjoys golf and hiking and playing fetch with his Norwich Terrier, Chester. While still maintaining a residence in Manhattan where Andris serves as President of the coop Board, Andris and his wife, Sarah Lee, have been part-time residents of Washington since 1998 and were married at St. John's. They are enthusiastically engaged in all aspects of parish life and are also supporters of local conservation organizations.

#### WARDENS' REPORT

St. John's has been a presence in the Washington community for over 226 years. Although 2019 was a transition year for St. John's, we continued once again to fulfill our primary mission by gathering for over 110 services. We accomplished this, and the many other achievements described by our guilds and committees, through the contributions and steadfastness of our parishioners and other friends of this parish. It was particularly gratifying that we had a number of parishioners step up to lead Morning Prayer on the occasions when we did not have the presence of a priest. We also were privileged to benefit from the presence of a variety of talented supply clergy: Bishop Whitmore, Fr. Woodroofe, Fr. Klots, Fr. Pople, Pastor Krentz-Wie and, last but not least, Fr. Hahneman. We also were visited twice by our Bishop Diocesan, Bishop Douglas, who remarked that in the past year, through no plans of his own, he had become more familiar with St. John's than with any other parish in the State. That attention and our many conversations with Bishop Douglas paid off with the appointment of Fr. Geoff as our new Priest in Charge. As it turns out, we didn't think Fr. Geoff really stood a chance of escaping us, as he was being pursued simultaneously by the wardens to serve as openended supply and by Bishop Douglas to accept an appointment as PIC. No doubt, the Holy Spirit was at work!

The general upwards path of the parish over the past year has been tremendous, with increasing participation and attendance numbers, a successful stewardship campaign, a wonderful children's theatrical production, an amazing Bazaar, successful potluck dinners and receptions, various outreach efforts, beautiful flowers, a steadfast Altar Guild and a revived choir and music program, all of which are described in greater detail elsewhere in this report.

On behalf of the entire parish, we would like to thank our dedicated staff and each one of you who have contributed to the reinvigoration of St. John's over the past year. In particular, we would like to thank Hunter Brown and Holly Flor for their service on the vestry. We need to continue to grow in many directions, and we look forward to your prayers, participation and support under the leadership of our new priest, Fr. Geoff, to make 2020 a successful year for St. John's.

#### TREASURER'S REPORT FOR 2019

Operating Income in 2019 totaled \$307,242 and expenses totaled \$318,316 creating a deficit of \$11,073. The 2019 budget presented at the annual meeting projected a \$66,000 deficit for the year. Pledge income was up \$4,000 over budget and Restricted Funds (not operational) of \$29,000 plus the rental income generated by the Cottage and Parish Hall helped the bottom line. Going forward cost saving steps initiated by the Vestry will reduce ongoing office expenses by an estimated 20%.

The 2020 budget projects total income of \$287,837 which reflects a \$30,000 increase in pledges above 2019. We used a conservative estimate of plate contributions, Bazaar and other non-pledge income, as it is difficult to forecast those items. Additionally, the Endowment Fund Disbursement was reduced from 6.52% (2019) to the recommended amount of 4.5%. Finally, we budgeted only 6 months of cottage rental income; however the Vestry will aggressively look to capitalize on all of our property.

Expenses are estimated to be \$307,603 which is \$11,000 lower than 2019 actuals. Reduction in Clerical and Common Mission Support expenses were the major contributors in lowering expenses as most other costs increased. As we begin the New Year, we are pleased to report we are in good standing with Diocese as all dues have been paid.

The 2020 budget forecast a deficit of \$19,766. We will continue to explore new opportunities to increase revenues and reduce expenses.

#### **ALTAR GUILD REPORT FOR 2019**

#### **Caroline Thompson**

This has been a year of rebuilding for the Altar Guild at St. John's, Washington. We have added three new members, Douglas Holtquist, Richard Thompson, and Sara Coles, which means that we have all services for 8 and 10 am covered. We welcome more members to join us, so that we could return to working in pairs.

Early in Christianity, worship began in homes and evolved to worship in churches as Christians multiplied. By the 4th century, worship services had evolved into formal liturgies specific to the season and particular celebration. Beginning then, and for hundreds of years thereafter, clergy and lay leaders (exclusively male) became responsible for preparing for the services, doing the church housekeeping and caring for the paraphernalia of worship, most of which remains the work of present-day altar guilds. The work goes on quietly behind the scene as members prepare all the elements needed for each service.

A description of the work of the Altar Guild from our Manual says it best:

"Service on the Altar Guild is a sacred ministry undertaken in love and dedication by men and women who are called by God to prepare and tend the places where we worship. The Altar Guild has a special role as the Priest's liturgical partner in making the worship life of the parish run smoothly. The work you do together is an offering of time and talent, and the Church is grateful for your devotion to this important work."

From time to time, we need new Vestments, Paraments, Eucharistic elements and linens. Parishioners have been generous in donating many of these items, often as a lasting memorial to a loved one. We have a number of items we currently need. Contact the Priest-in-Charge if you would like to make a gift.

#### **BUILDINGS AND GROUNDS REPORT FOR 2019**

#### **Charles Dubow**

- Thanks to the generosity of Ginny and Rob Reynolds, the grounds of the campus received the first proper trimming in years.
- We are current with all our service providers, including Mitchell Oil, Berkshire Alarm, etc.
  - Oil: We pay a fixed sum monthly of \$1400 to Mitchell and pay a balloon payment in late December early January.
  - Our snow/lawn service is a new company. They purchased Domus in the late spring of 2019. They seem to be doing a pretty good job though we do need to decide if we want to contract with them to shovel the walkways when Jorge is not around and if spring and fall cleanup are items we want to spend the money on next season.
  - o In regard to maintenance expenditures for the 2019 year:
    - We updated outdoor flood lights on the Parish House and Rectory
    - We replaced a faucet in the Sacristry
    - We had to spend around \$2100 to fix the AC system
- And had to fix the refrigerator in the Rectory and stove in Parish House Looking ahead in 2020
  - Two of the top priorities for 2020 are generating rental income from the Rectory and Cottage.
    - o There has been agreement that the Rectory should be rented out on an annual basis.
    - o There is still discussion about whether the Cottage should be a) rented annually or b) whether it should be placed on AirBNB or VRBO.
      - It is my opinion that we should NOT choose option (b) as that will mean we will need to change and clean the Cottage before and after each rental.
    - Whatever decision we make, we are still required to comply with the rules of the Diocese regarding rental of church property.

    - We should initiate the process of renting these properties as soon as possible.
  - Repair of Church doors:
    - o Both the front and side-doors—including the doors themselves and surrounding masonry—are in need of repair. It is unlikely that we will have the funds to fix either of them.
    - o Funds for repairs can come only from generous donors. Would it be possible to offer naming rights for the doors by placing a plaque by each door with the names of those who donated?
  - Spring clean-up:
    - In an effort to reduce costs and enhance a sense of community, we should organize a spring clean-up day in early-April—Saturday the 4<sup>th</sup> (or the last weekend in March, 28<sup>th</sup>)

We wish to encourage all to join us in this gratifying effort of delivering scripture to the parish through the gift of reading and assisting with the Eucharist.

#### 2020 STEWARDSHIP REPORT

Stewardship Committee, Tom Hollinger, MB Witt and Larry Littlefield.

In the fall of 2019 the Stewardship Committee initiated its work meeting several times after the departure of Bishop Whitmore and before the appointment of Father Hahneman. With the appointment of Father Hahneman as Priest in Charge we were confident that our campaign would be aided by that good news and we began in earnest.

Our initial mailing of pledge packets went to approximately 75 families/individuals, a decrease from prior years as the result of a review of actual voting parish members. In addition, a group of volunteers were assigned to call parishioners. I am pleased to report that as of this writing, we have received 50 pledges totaling \$197,590 which exceeds last year's total of \$159,690. It is, however, just short of our goal of \$200,000. It is important to put that in perspective, in 2018 pledges total \$232,132; however, at that time there were more families on the church rolls. Another example is 2015, 149 pledge packets were mailed with a response of \$207,000 pledge. So despite a decreased number of packets mailed for 2020, the dollars pledged represents strong support from the current parish family. We are profoundly appreciative of all those who have pledged.

#### A breakdown of the pledges is as follows:

50 pledges for a total of \$197,590 11 new pledges for a total of \$23,700 18 parishioners increased their pledges for a total of \$26,900 7 parishioners decreased their pledges by \$8050 14 parishioners remained at the same level

#### **OUTREACH REPORT FOR 2019**

#### Véronique Dulack

2019 was a very successful year for the St Elisabeth Guild thanks to everyone's growing interest, and great generosity and participation. In addition to its yearly *Outreach Calendar* activities, Outreach expanded significantly with the first time ever undertaking of a Music, Theater and Dance summer camp that culminated in two performances of *The Rainy Days and Nights of Mr. and Mrs. Noah* on July 26 and 27. It's the sort of activity that Outreach would like to duplicate in the future.

#### Contribution to The Washington - Warren Food Bank, which serves the local communities

- The manager of the food bank regularly updates the list of needed supplies depending on the time of year. These updated lists are included in the weekly e-blast. Supplies are picked up every month. Most of the families the food bank serves are households of just one or two people. Smaller jars and containers of nonperishable food are preferred (canned vegetables, fruits and soups, cereals and pasta, pasta sauces condiments, juice, flour). Thanks to a grant, the food bank has recently been able to buy a large freezer, making it possible to receive donations of perishable food as well. Hygiene and cleaning products are also very welcome as these items cannot be purchased with food stamps.

True to the tradition, Saint John's parishioners donated 15 pies to supplement the town's Thanksgiving Food Baskets.

#### Partnership with The Covenant to Care for Children

Covenant to Care for Children is an organization based in Hartford which provides and distributes statewide, essential goods for children from birth up to 18 years old. That mission is fulfilled by partnering with state agencies, faith-based communities and other organizations that share a dedication to improving the lives and futures of at-risk children in CT.

These are children facing poverty-driven issues whose families are among the working poor. Every child's need is identified and reported by a social worker, enabling us to respond directly to the recipient's specific requests.

#### - Christmas Angel Tree: chaired by Marlene Smith

Once again St. John's parish participated in the Angel Tree project in collaboration with Covenant to Care for Children. This year, requests from 25 children were filled by our parishioners. Despite the short time between getting the requests and the Sunday they needed to be returned to church, all requests were filled and my over-flowing station wagon made a delivery to a staff member who would ferry them to Hartford to be distributed.

I am extremely grateful to Sarah for her important help in creating tags at a time when there were many things she had to attend to. Also, Jorge gave me wonderful help with erecting the Angel Tree. Thank you. And thank you to the parishioners who gave generously to these children in need.

#### - Easter Baskets: chaired by Natalie Dyer

In lieu of Easter Baskets, the CCC suggested that donations of hygiene and cleaning products would be more useful to the families they serve. A month before Easter, boxes were placed in the Parish House to collect donations which were most generously provided by parishioners. CCC was extremely grateful for the supplies which they distributed to families in need.

#### - Back to School Backpacks: chaired by Veronique Dulack

In early August a carload of donations was delivered to Covenant to Care for Children who this year requested a wide choice of school supplies needed by children from 10 to 15 years old. The Back to School Backpacks is one of the most important drives of The Covenant to Care for Children who distribute over 850 backpacks.

#### "The Rainy Days and Nights of Mr. and Mrs. Noah" Tom Dulack

In the summer of 2019 the church sponsored as a first-time Outreach project for a community that eventually stretched from Naugatuck to Litchfield, a summer arts camp on the church campus that lasted for the first three weeks of July and culminated in an original musical drama entitled "The Rainy Days and Nights of Mr. and Mrs. Noah." We offered three weeks of professional teaching by artists with credits on and off Broadway in NYC as well as with the Los Angeles Opera to name a few virtually free of charge (a nominal fee of 50 dollars covered everything for the three weeks of camp). In the end we assembled a student contingent of 17 performers from ages four-and-a-half to twenty-one! We had two girls from Russia visiting for the summer who despite limited English became leaders of the company. We had a UConn music student playing the church organ for the show, assisted by his mother, a professional musician with cultural roots also in Russia. Dance instruction, singing and acting instruction went on every day for about 6 hours a day, and for the final week of straight rehearsals sometimes much longer. On a weekend in late July when we were competing with shows at the Gunnery, at the Congregational Church, and at the town fair in New Milford, we half-filled the church on a Friday night for an invited dress rehearsal and then played the following night to a standing crowd that was over the top in their enthusiasm. This was a huge event for St. John's and had a very positive effect on the community. We introduced an audience that only partly consisted of St John parishioners and impressed all our visitors who continued to express their enthusiasm to us weeks after the event

#### **BAZAAR 2019**

2019 Marked the 30th anniversary of the St. John's Bazaar. In the midst of St. John's continuing transition, the Bazaar was a financial success.

# The Report of the Priest-in-Charge

St. John's is a church in transition, from a congregation led by a priest and supported by the lay leaders, to a congregation led by the lay leaders and supported by a priest!

I borrowed this language from Andy Doyle, the Bishop of Texas, from one of his many books about the changing church of our days. I think it captures a sense of where St. John's is today, indeed where much of the Christian Church is these days. Fewer and fewer congregations in this country can afford the kind of clerical staff and corporate business practices of their parents' churches. But the church of our parents' need not be the model for our generation.

St. John's in Bridgeport, from which I retired in September, was founded in 1748 by seven farming families in the fields between the village of Fairfield and that of Stratford. Clergy were hard to come by in colonial America. One fifth of all those who headed off to be ordained in England, as there were no bishops to ordain them in the colonies, died before they returned. So these seven farming families were not waiting around for a priest to come and found their church. They did it! They purchased the land and buildt the first small wooden church at the corner of Church Street and the King's Highway themselves! For the next 35 years, they had no priest to call their own. They organized Sunday Services, cared for the sick, buried their dead. When an occasional New York priest on holiday, or a missionary from England and the Society for the Propagation of the Gospel in Foreign Parts passed through, children were baptized, couples were married, and Holy Communion was celebrated. Even when that church in Bridgeport secured their first Rector in 1783, they had to share him with two other neighboring congregations.

So that is why I intend to spend much of my time in the year ahead helping to train the lay leaders of this parish to care for themselves and for the community in which we find ourselves. I am holding open Saturday mornings for such training, which will include Lectors, Ushers, Acolytes, Altar Guild, Pastoral Team, Prayer Circle, Property Committee, Youth Leaders, Catechists, Eucharistic Visitors, Altar Flower Deliverers, Worship Leaders, Outreach Team, Fellowship organizers, Vestry Members, Auditors, Choir Members, Eucharistic Ministers (aka chalicers), and so much, much more.

God has given all of us gifts and talents to use in the mission and ministry for God's people. I invite and encourage every member of St. John's to quit any 'jobs' they have in the parish, and to find their 'ministries'! "What in God's Name are you doing here?" Remember, the Christian Church is NOT a spectator sport!
